COMMITTEE UPDATES

Government & Professional Relations Committee

Addressing mental health, intervention services, and parent engagement continue to pose challenges, as well as opportunities, in our schools. With the close of the most recent legislative session, districts and schools have been grappling with ways to meet the various needs of their students and communities while upholding state mandates. There are several ways you can engage in the discussion and find ways to meaningfully impact the schools that you serve.

The New Nevada Education Funding Plan (2017) is one such opportunity. SB178 prescribes changes to the statewide average basic support guarantee (per pupil expenditure) for the next biennium. These changes include “additional resources expressed as a multiplier of the basic support guarantee, to meet the unique needs of certain categories of pupils...These additional resources are expressed as a multiplier of the basic support guarantee per pupil. (NRS 387.121, 388.429).” These certain categories of students include those who are English learners or are eligible for a free or reduced-price lunch, scored at or below the 25th percentile on an assessment of proficiency, are not enrolled at a Zoom or Victory school, and do not have an IEP. For full descriptions of the categories, see Section 8 of the bill. In other words, students who fall under these categories may qualify as students eligible for [their schools to receive] the additional resources pending certain criteria expressed in the bill.

If a school does receive money according to Section 8, it must use 90% or more of the money on extended learning opportunities, academic interventions, early childhood education, or another approved strategy. In addition to using the monies for one or more of the aforementioned activities, the school may also elect to spend up to 10% of the money (10% of the 90%) on 1) programs and services designed to engage parents and families, 2) programs to improve school climate and culture, or 3) services to improve students’ and families social, psychological, or health status. *This is at the heart of what school psychologists do!*

Understanding the law and knowing how we can contribute is key to making change. We can use this knowledge to advocate for our students and help school leaders make meaningful and impactful decisions. The following tips are offered to facilitate discussions with school leaders regarding opportunities for change:

Be a Resource. Share that you are familiar with SB178 and offer yourself as a resource to help make decisions regarding ways to engage parents, how to improve school climate and culture, or ways to improve the social and psychological status of the students.

Engage in Implementation. In addition to being a resource, offer to actively engage in any change innovation you suggest. Request that the available funds, up to 10% of the 90%, be spent on social-emotional and mental health programs and services.

Have Conversations. Engage in conversations at your schools surrounding the use of funds, and then share the information with your school psychologist colleagues. Sharing ideas about what works, and what hasn’t worked yet, could be advantageous to a school psychologist on another campus.

Unless we try, we never know what could be.

Communications Committee

The Communications Committee has been hard at work this month. As you can see, we have managed to develop our first full-length newsletter and are excited to continue the momentum. We have also been working hard to update and improve the NVASP website to make it easy to navigate. The Communications Committee will soon begin working on revamping the NVASP “brand” by updating our logo.



COMMITTEE UPDATES

Shortages Committee

The Shortages Committee is working on a number of tasks to tackle the shortages across the state of Nevada. We are currently reviewing the Professional Growth System Reference Guide to align accepted professional growth standards with those required by NASP for our NCSP certification. With that, the committee hopes to be able to revise other CU-earning options to better reflect the number of reports and MDTs that one a SP's caseload in any given year. Furthermore, we are also advocating for districts to acknowledge the credits of graduate level training that SPs must obtain prior to obtaining a license to practice in the state of Nevada.

The shortages committee is also working with the Government and Professional Relations committee to address better reflection of SPs in Nevada state educational laws. For example, ensuring that SPs are required, by law, to be supervised and evaluated by licensed SPs. Or by having state law reflect caseload numbers that are consistent with NASP guidelines and best practices. Finally, the committee is continuing to gather state-wide shortage data. Most recent data is from 2015-2016 school year, indicating a shortage of 33 SPs across the state of Nevada.

Awareness & Promotion Committee

Responsibilities of the Awareness & Promotion Committee include: 1) Outreach to undergraduate psychology and education programs across the nation to attract high-quality applicants to the school psychology graduate program(s) within the state and 1) Outreach to state school psychology organizations to advertise employment opportunities and benefits within the state. Strategies may include direct in-person contact, participation and advertisement in conferences, email, social media, and distribution of promotional materials.

This first Lecture Series event takes a team-based approach to how education professionals can work together to meet the mental health needs of our students.
